#### OIL & PIPELINE COMMITTEE REPORT JEREMY MILLER & PAUL MCMAHAN

The Oil and Gas Pipeline committee is excited to announce the addition of Jeremy J. Miller, Business Development Manager for Oil & Gas

and Utilities for LW Survey Company, to the IRWA Chapter 31 - Oil and Gas Pipeline Committee. Kevin Muldowney stepped down.

The committee reports that due to the extensive cold weather in parts of the country there will be a consequence of reduced oil production. The deep freeze havoc will likely affect production for weeks as companies deal with frozen equipment and lack of power to run operations.

Texas who produces more oil and gas than any other state was especially hit hard by the freeze due to not being accustomed to dealing with frigid temperatures. Texas has recently experienced their coldest temperatures in thirty years. North Dakota experienced temperatures as low as minus 50 degrees Fahrenheit. Some wells were frozen. Additionally, rolling electrical blackouts and difficulty in travel throughout the regions have halted or reduced production.

In addition to the impact of winter weather, the Oil & Gas industry is experiencing significant challenges under the new Administration, most notably the cancellation of the Keystone XL Pipeline and potential halting of the Dakota Access Pipeline. Employees across the industry, both Union and non-Union, along with Tribal leaders have voiced their concerns as jobs have been cut and production has been halted. As such, support is slowly growing, possibly even across both sides of the aisle, as select lawmakers aim to address the impact of these widespread climate executive orders.

Good news for Natural Gas; after decades of stagnation and multiple false starts, the hydrogen economy is finally taking off, with some experts predicting that hydrogen could become a globally traded energy source, just like oil and gas. Those gases can now be captured, cleaned up and used interchangeably with conventional natural gas. And with Shell's \$6 billion ethane cracker plant close to completion, the market for Marcellus/Utica NGLs will profoundly change.

We all need to remember that the Oil & Gas industry is resilient, we are resilient, and with new ways of improving fossil fuel production, transportation, storage and refinery, there will come new and exciting opportunities for everyone. Continue to stay focused and strong, the industry needs our determination and support now, more than ever.

## Remembering George Edwards Midgett

It is with great sadness that we announce the passing of George Edwards Midgett, SR/WA, a loyal and dedicated International President of IRWA and long-time leader with Duke Power Company, the predecessor company of today's Duke Energy Corporation. George was born on October 8,



1924 in Engelhard, a coastal town in Hyde County, NC.He passed away on August 27, 2020 in St. Petersburg, FL following a long battle with cancer.

George was a naval aviator during World War II and flew torpedo bombers. He attended The Citadel and graduated from Duke University after the war. George joined Duke Power on November 1, 1948 and held numerous management roles of increasing responsibilities culminating in leading Duke's Real Estate Division for several years. He retired from Duke Power after 36 years of service on November 1, 1984.

During his tenure at Duke Power, George was a strong supporter of IRWA and its educational programs. Not only was he an instructor in the negotiations discipline for the Association's original Principles in Land Acquisition course, but George also ensured all of Duke's right of way agents and staff appraisers successfully completed that course. He was the 1973 recipient of the Frank C. Balfour Professional of the Year Award, served as Carolinas Chapter 31 President in 1977 and IRWA International President 1980-1981.

George was preceded in death by his wife Loretta on August 10, 2017 after 71 years together. They had relocated from the Charlotte, NC area to Florida in March of 2017.George is survived by his sons David and Robert, his granddaughter Jahni and his great granddaughter Jasper.Memorials may be sent to the Right of Way International Education Foundation in George's honor.
