



Old Business


- The new Website is still in the process of being worked on and should be fully operational shortly. More information to follow.



Did you know???

Relocation Corner

DID YOU KNOW???

The first time an agency makes an offer to purchase; it must be in writing and be in the full amount approved by the agency as its estimate of just compensation. Subsequent formal offers and notices are also required to be in writing. This does not preclude the use of verbal discussions during negotiations to arrive at an agreed purchase price for the property, depending upon agency policy and applicable law.

DID YOU KNOW???

The possibility of an administrative settlement should be explored, reference 24.102(i). Agency officials may approve the use of an administrative settlement if it is reasonable, prudent and in the public interest. Agencies may also use other alternative dispute resolution options, such as mediation and arbitration. If all efforts to negotiate/settle fail then the laws of the agency set forth the legal steps the agency must take when they wish to purchase property that an owner does not want to sell.
