Chapter 31 Comes
Up Short on Votes!!!

Carolinas Chapter 31 went to this year's IRWA Educational Conference in Anchorage Alaska vying to bring the Conference to Charlotte again for 2022. We last hosted the annual affair in Charlotte in 1992 when the format and Chapter responsibilities were much different. After hearing from so many about how successful and fun that year was we decided that it was about time for that to happen again. Our Chapter has grown in recent years to be one of the largest and most active in our association. We thought the timing was right for a 30-year anniversary.

Unlike our competition we have expressed low key interest in recent years and tested the waters mildly in Nashville with our blue bracelets. Denver and Cleveland have been making significant investments toward their bids. We knew the competition would be strong compared with many years. "Charlotte's Got a Lot"...and we knew the Carolinas offered so much more. Come watch our video presentation at our Summer Chapter meeting in Charlotte.





When it came time for the Board to vote we expected a run-off vote since typically no one gets more than half the vote when three or more are competing. Denver Chapter 6 and Carolinas Chapter 31 were shocked when Ohio Chapter 13 received almost 2/3 of the initial vote leaving us far behind but close to each other. We're unsure of the rationale for such overwhelming support for Cleveland. Was it the lower room rate, the free venue for the Monday Night event at the Rock & Roll Hall of Fame, a higher level of enthusiasm or just that it had been 50 years since last going to Cleveland?

Nevertheless, we raised the profile of the Carolinas and received a lot of compliments regarding our efforts. Our Chapter and Region volunteers made us proud as we were recognizable by our shirts, our hospitality, and our numbers in Alaska. We have already been asked would we try again. Fortunately, we'll have some time to consider as IRWA will now move to a three-year cycle for these decisions instead of our former five-year cycle. This means the host for 2023 will not be decided until the conference in 2020.

RELOCATION CORNER

DID YOU KNOW???

Question: In areas where houses sell for a premium over the list price, can the relocation agent adjust the relocation housing payment to account for this premium?

Answer: The regulation does not call for adjusting the asking price, either upward or downward. The regulation does say the comparable must be available. If a comparable is not available for the amount calculated, a new calculation may be in order.

DID YOU KNOW???

Question: Can the required early notice be provided at a public meeting? When is the best time to give this notice?

Answer: No. When property is to be acquired, each owner should be notified in such a way that an administrative record exists to attest to the delivery to the owner. There is no assurance when using a public meeting that all affected owners will be present and each owner is due the courtesy of receiving a tinely notice of the agency's intent. The notice should be provided as early as possible, when it is known a property interest will be acquired, and no later than when the appraisal or waiver valuation assignments are made.




